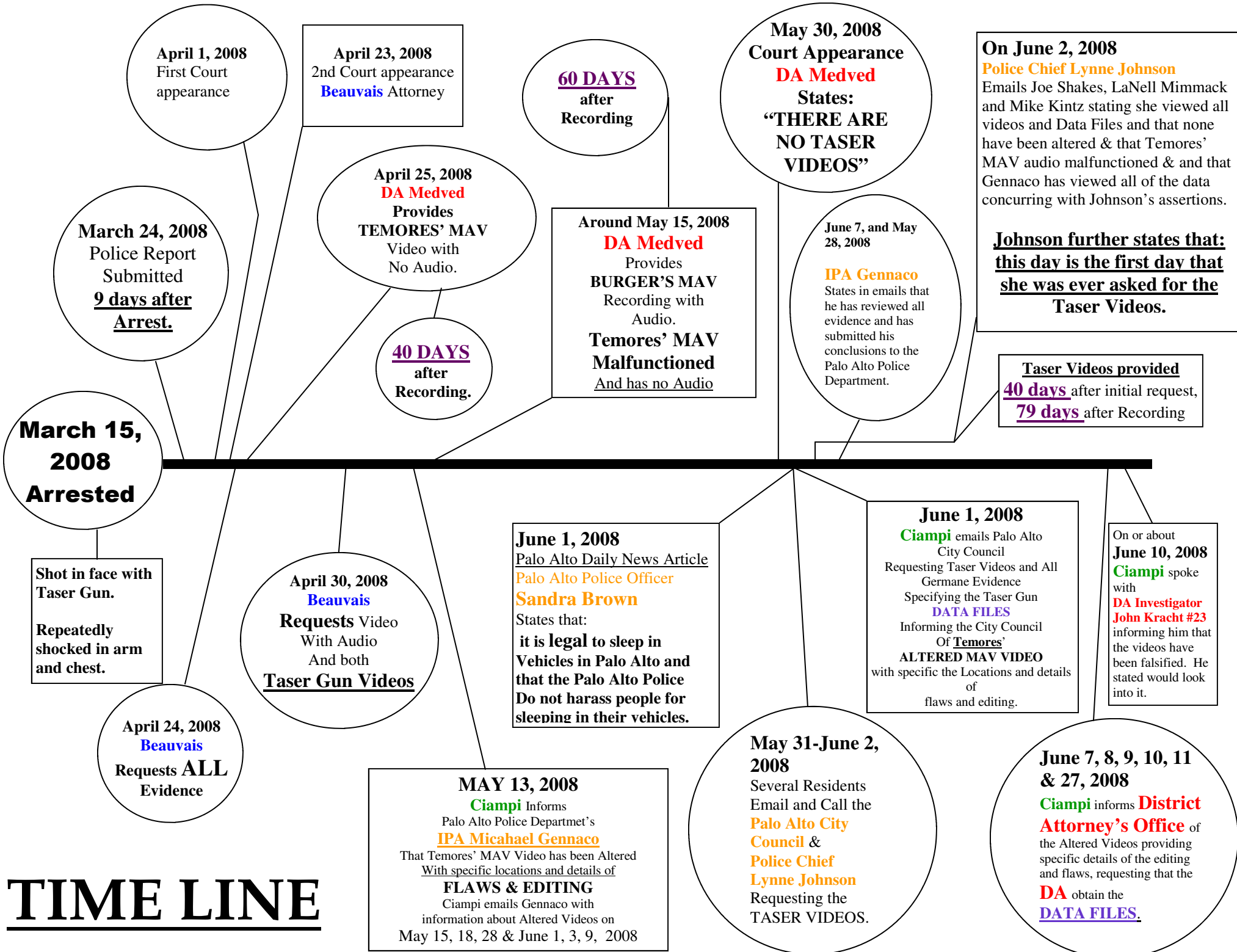


# TIME LINE



**March 15, 2008 Arrested**

Shot in face with Taser Gun.  
Repeatedly shocked in arm and chest.

April 24, 2008 Beauvais Requests ALL Evidence

March 24, 2008 Police Report Submitted 9 days after Arrest.

April 1, 2008 First Court appearance

April 23, 2008 2nd Court appearance Beauvais Attorney

April 25, 2008 DA Medved Provides TEMORES' MAV Video with No Audio.

40 DAYS after Recording.

April 30, 2008 Beauvais Requests Video With Audio And both Taser Gun Videos

60 DAYS after Recording

Around May 15, 2008 DA Medved Provides BURGER'S MAV Recording with Audio. Temores' MAV Malfunctioned And has no Audio

May 30, 2008 Court Appearance DA Medved States: "THERE ARE NO TASER VIDEOS"

June 7, and May 28, 2008 IPA Gennaco States in emails that he has reviewed all evidence and has submitted his conclusions to the Palo Alto Police Department.

On June 2, 2008 Police Chief Lynne Johnson Emails Joe Shakes, LaNell Mimmack and Mike Kintz stating she viewed all videos and Data Files and that none have been altered & that Temores' MAV audio malfunctioned & that Gennaco has viewed all of the data concurring with Johnson's assertions.  
Johnson further states that: this day is the first day that she was ever asked for the Taser Videos.

Taser Videos provided 40 days after initial request, 79 days after Recording

June 1, 2008 Palo Alto Daily News Article Palo Alto Police Officer Sandra Brown States that: it is legal to sleep in Vehicles in Palo Alto and that the Palo Alto Police Do not harass people for sleeping in their vehicles.

June 1, 2008 Ciampi emails Palo Alto City Council Requesting Taser Videos and All Germane Evidence Specifying the Taser Gun DATA FILES Informing the City Council Of Temores' ALTERED MAV VIDEO with specific the Locations and details of flaws and editing.

On or about June 10, 2008 Ciampi spoke with DA Investigator John Kracht #23 informing him that the videos have been falsified. He stated would look into it.

MAY 13, 2008 Ciampi Informs Palo Alto Police Department's IPA Micahael Gennaco That Temores' MAV Video has been Altered With specific locations and details of FLAWS & EDITING Ciampi emails Gennaco with information about Altered Videos on May 15, 18, 28 & June 1, 3, 9, 2008

May 31-June 2, 2008 Several Residents Email and Call the Palo Alto City Council & Police Chief Lynne Johnson Requesting the TASER VIDEOS.

June 7, 8, 9, 10, 11 & 27, 2008 Ciampi informs District Attorney's Office of the Altered Videos providing specific details of the editing and flaws, requesting that the DA obtain the DATA FILES.

**June 24, 2008**

Court appearance, **DA Medved LIES** to Beauvais stating that the Attorney General is investigating the video recordings, when he was not.

**Mid July, 2008**

**Beauvais** subpoenas the Police Department for the **DATA FILES** and the remainder of the evidence.

**The Police Department** refuses to provide the **DATA FILES** and other evidence, stating that it is the wrong process.

**July 30, 2008** Palo Alto Daily News Article

**DA Medved** states that she has provided all the evidence to Beauvais yet Beauvais and Ciampi still had not received the **DATA FILE** reports.

Palo Alto Assistant City Attorney **Donald Larkin** stated, "There is no subpoena for records from a police department in a criminal case,"

**Assistant Police Chief Dennis Burns** stated, "“If it hasn't already been provided, it will be.” he said. Ciampi is "entitled to everything the prosecution has that is germane to the case," Burns said.

**Burns** could not verify Tuesday whether the data had been sent to Medved's office and said **it is possible the data downloads are still awaiting transfer.**

**September 8, 2008**

**DA Medved** informs Beauvais that original videos are just now being sent from Police Department to the Crime Lab.

**October 15, 2008**

**District Attorney's Office** still prosecuting **Ciampi** even though videos have been edited and falsified

**Early July, 2008**

**DA Medved** states to Beauvais that he must subpoena the police department for the remainder of the evidence including the **DATA FILES** knowing that subpoenaing the police is the wrong procedure to obtain evidence in a

**September 16, 2008**

Court appearance **DA Medved** states that the Crime Lab was receiving the original videos this day, a contradiction to what she Stated on the 8th.

**DA finally investigates altered videos 100 DAYS**

After first being informed of Altered videos And **28 DAYS** after receiving Forensic Experts Analysis.

**November 5, 2008**

**Medved** stated that the **Crime Lab's** Analysis would be ready and available by October 15 and then October 29, 2008. Crime Lab's analysis still not ready.

**June 5 & 18, 2008**

**Ciampi** requests from the Palo Alto City Council the **DATA FILES**, the Maintenance & Dispatch reports on Temores' malfunctioning MAV system and informs the City Council of other specific details of the editing of the FOUR

**July 27, 2008**

**Ciampi** informs the **Palo Alto City Council** that their police department refuses to provide the **DATA FILES** from the taser guns violating their own Use of Force Policy 308.96 which states that the Data File reports will be included with the original Police Report.

**August 5, 2008**

**Ciampi** files complaint with **IPA Gennaco** concerning the violation of Use of Force Policy 308.96. **(Data Files should be submitted with original police report.)** Gennaco refuses to investigate complaint.

**August 13, 2008**

**Beauvais** receives the **DATA FILES** **142 days** after the **DATA FILES** should have been submitted with the original Police Report

**August 18, 2008**

Court appearance, **Beauvais** provides **DA Medved** with **Stutcham's Forensic Report** verifying that the videos have been edited, altered and are missing content.

**September 9, 2008**

**Ciampi** provides the **Crime Lab** and the **DA's Office** with more extensive analysis' of the Four recordings and the **Data Files.**

**June 2, 2008**

**Lynne Johnson** and **Dennis Burns** submit quarterly report stating that **Ciampi** was leering at RP's wife and children which is an out right **LIE.**

**July 7, August 4, September 23, October 30 & January 5**

**Ciampi** files complaint about the **Palo Alto Police Department** and **DA Medved** with the **State Attorney General's Office** informing the AG that **DA Medved** is withholding evidence and that the FOUR VIDEOS submitted to the DA by the Palo Alto Police have been altered and falsified, providing the AG with specific details of the flaws and editing as well as **Stutchman's Forensic Analysis** on September 23, 2008.

**September 9, 2008 Ciampi** provides Temores' MAV Video and the Data File analysis's to the **DA.**

**December 1, 2008**  
**Ciampi's Pre-Trial begins.**  
**DA Javier Alcala** offers Ciampi the following plea deal minutes before the Pre-Trial Begins and after **NINE** months of prosecuting **Ciampi**:

"Disturbing the Peace" Misdemeanor, "Time Served," (12 hours) and a year probation.

**DA Javier Alcala**  
**Does Not Use any of the Videos or Audios in the Pre-Trial Hearing.**

Pre-Trial begins and proceeds from **December 1, 2008** through **December 17, 2008**, yet **DA Javier Alcala** and the **Crime Lab** refused to provide Ciampi and his Attorney with the **Crime Lab's** analysis of the videos.

**DDA Javier Alcala** shows Palo Alto Daily News Reporter **Will Oremus** Temores' MAV video prior to the completion of the Pre-Trial Hearing and before Judge Thang Barrett dismisses the case on **December 17, 2008**

**December 17, 2008**  
**Superior Court Judge Thang Barrett** dismisses the case based upon the illegal actions of the Palo Alto Police Officers.

He does not hear any of the evidence about the falsified evidence .

**DDA Javier Alcala, DA Dolores Carr,** and the **Crime Lab** refuse to this day, **December 23, 2008** to provide me with the **Crime Lab's** analysis and report of the videos.

**On January 2, 2009**  
Palo Alto Police Sergeant **Natasha Powers** filed a false complaint against **Ciampi**.  
**Powers** falsely alleges that **Ciampi** threatened her on **September 10, 2008** at 9:00pm on the 300 block of Waverely st. Powers waited four months and two weeks after Ciampi's criminal case was dismissed to file the complaint against **Ciampi**
