D: Dispatch, Palo Alto Police

RP: Yes sir. I've got a guy who parks and lives in- a- ah- van outside of my house and ah I've asked him.....

D: Is here there now?

RP: He's there now. He stays here, you know, weeks on end. He may move his car a foot or two so he, you know, he technically doesn't violate. I've asked him, I've said look, I don't care. He scares the daylights out of my wife. And I've asked him to, you know, you know, spread the wealth. You know, park somewhere else a couple of nights or something. He's just, you know, an obstinate son of a gun. Ties his bicycle up to the tree. I don't know where he goes to the bathroom.

D: Ok, what's the location?

RP: It's at the corner of Lincoln and Ramona. He parks on Lincoln. And his license number is I5073961. **My wife's coming back** . .

D: What color van is it?

RP: It's a blue van. An older one. I don't know the, you know, I don't know ...

D: And what's the guy look like?

RP: He's a young guy.

D: White, black, Hispanic or Asian?

RP: He's, ah, he's anglo.

D: Ok, approximately how old?

RP: I would guess he's 30.

D: **All right. Has he threatened your wife?**

RP: **No**. You know. It's just, he's out there, like I said. I have no idea what he does to relieve himself. Ah, he's ah, and he's there like he'll be gone a week or so and then he'll be back for three weeks at a time. And so I finally, you know, I went up and I, I said hey, please just, you know, you know, spread the wealth for god sakes. And you know, he was

D: **Yeah, just to let you know, there really, we have no law against living in a vehicle.** I'm just letting you be aware of that. But I will, I will, ah

D Well, I'll put that on the call. It makes, you know, that it makes your wife uncomfortable.

RP: Yeah, My young daughter's coming back from school. Yeah, uh . .

D: Daughters, yeah.

RP: I have no idea where this guy's brain is.

D: We'll check it out. And your last name?

RP: Alsman, A-L-S-M-A-N. I live at . . .

D: And first name?

RP: Ken. And I live at 1057 Ramona Street.

D: 1057 Ramona. Ok. And your phone number?

RP: Well, my cell phone is xxxx 533-8070

D: Ok, well, ah

RP: I sure, I sure appreciate it.
